THE ACCA QUALIFICATION

The <u>ACCA Qualification</u> comprises three exam stages, an Ethics and Professional Skills module, and a Professional Experience Requirement (as shown in the figure below). This qualification equips students with the most current skills required to become a finance professional.

- **1. Exams** The three stages of exams are Applied Knowledge exams (3 papers), Applied Skills exams (6 papers) and Strategic Professional exams (2 Essential and 2 out of 4 Optional Papers). Some of these papers are exempt depending on whether previous qualifications meet the requirements for exemptions.
- **2. Ethics and Professional Skills** The Ethics and Professional Skills module is designed to develop the complete range of skills that employers expect.
- **3. Practical Experience Requirement** As well as completing exams and the ethics module, students need three years' practical experience in a relevant role to qualify.

There is no time limit for Applied Knowledge and Applied Skills exams, but remaining exams must be completed within 7 years of passing first Strategic Professional exam. Completion of Applied Knowledge, Applied Skills exams, and Ethics and Professional Skills module earns Advanced Diploma in Accounting and Business.

FOUNDATIONS IN ACCOUNTANCY

This is for those unable to meet the minimum requirements, serving as an entry route for ACCA Qualification.

Once these exams and a Foundations in Professionalism module are completed, the student automatically moves into the ACCA Qualification, unless they have opted out of automatic transfer or chose to get transferred after all 9 FIA papers via myACCA.

DIPLOMA IN INTERNATIONAL FINANCIAL REPORTING (DipIFR)

This is for professionals who need knowledge of International Financial Reporting standards but don't require the full ACCA Qualification. The course focuses on developing knowledge, understanding, and application of IFRS and requires a single exam, held twice a year. It can be completed in 6 months.

The requirements for taking up DipIFR are:

- **1. Professional Qualification:** Qualified professional accountants or auditors who are members of an IFAC membership body, including CA (India) and CMA (India), are eligible for the ACCA financial reporting qualification.
- **2. No Professional Qualification:** If the student is working in practice/business/industry, but not yet qualified or not a member of an IFAC membership body, then meeting one of the following conditions is required:
 - Two years' relevant accounting experience and a relevant degree (attracting at least ACCA qualification exemptions for the Applied Knowledge and Corporate and Business Law (LW) exams). This includes any specialisation in Bachelor of Commerce degree. Check using the Exemptions Calculator.
 - Two years' relevant accounting experience and an ACCA Certificate in International Financial Reporting.
 - Three years' relevant accounting experience.
 - ACCA affiliate status.
